COMES NOW, the Complainant, Lloyd K. Jessen, and states:

1. He is the Executive Secretary/Director for the Iowa Board of Pharmacy Examiners and files this Statement of Charges solely in his official capacity.
2. The Board has jurisdiction in this matter pursuant to Iowa Code Chapters 155A and 272C (1997).
3. On July 23, 1993, the Board issued Respondent, Tonja M. Roland-Ludwig, a license to engage in the practice of pharmacy by examination as evidenced by license number 18064, subject to the laws of the State of Iowa and the rules of the Board.
4. License number 18064 is current and active until June 30, 1999.
5. Respondent's current address is 4034 Jill Drive, Waterloo 50701.
6. Respondent is currently employed as a pharmacist at Kimball Avenue Drug, 2104 Kimball Avenue, Waterloo, Iowa 50702 and Falls Road Drug, 1608 Union Road, Cedar Falls, Iowa 50613, and has been employed as such during all times relevant to this statement of charges.

COUNT I

The Respondent is charged with failing to provide adequate patient counseling, including but not limited to failing to provide warnings with respect to potential drug-drug interaction and manufacturer's patient package inserts or other written material about the prescribed medications to a patient under Iowa Code § 155A.12(1) and 657 Iowa Administrative Code §§ 8.20, 9.1(4)(b)(4).

THE CIRCUMSTANCES

1. On January 19, 1999, as part of a shopper survey conducted by the Board, the Respondent was presented with a new prescription drug order by a prospective patient.
2. One of the patient's prescriptions was for Coumadin.
3. The only information the Respondent gave the patient about the prescriptions were how to take them. The Respondent did not provide the patient with any other types of patient counseling and did not give the patient any written information about the medicines.

WHEREFORE, the Complainant prays that a hearing be held in this matter and that the Board take such action as it may deem to be appropriate under the law.

**STIPULATION
AND
CONSENT ORDER**

On this 15th day of July, 1999, the Iowa Board of Pharmacy Examiners and Tonja M. Roland-Ludwig, of 4034 Jill Drive, Waterloo, Iowa 50701, each hereby agree with the other and stipulate as follows:

The licensee disciplinary hearing pending before the Iowa Board of Pharmacy Examiners, on the allegations specified in the Statement of Charges filed against Respondent on April 14, 1999, shall be resolved without proceeding to hearing, as the parties have agreed to the following Stipulation and Consent Order:

1. That Respondent was issued a license to practice pharmacy in Iowa on the 23rd day of July, 1993, by examination as evidenced by Pharmacist License Number 18064, which is recorded in the permanent records of the Iowa Board of Pharmacy Examiners.
2. That Iowa Pharmacist License Number 18064 issued to Respondent is active and current until June 30, 2001.
3. That the Iowa Board of Pharmacy Examiners has jurisdiction over the parties and the subject matter herein.
4. A Statement of Charges was filed against Respondent on April 14, 1999.

5. This Stipulation and Consent Order is entered into in order to resolve disputed claims and constitutes no admission on the part of the Respondent.

6. Respondent agrees to accept a citation and warning for the allegations set forth in the Statement of Charges.

7. Within sixty (60) days of the date of approval of this Stipulation and Consent Order by the Board, the Respondent shall develop and submit to the Board, for its approval, a written policy and procedure for providing patient counseling as required by Board rules. Following review and approval by the Board, the Respondent agrees to adopt, implement, and adhere to this policy and procedure.

8. Within six (6) months of the date of approval of this Stipulation and Consent Order by the Board, the Respondent shall complete continuing pharmacy education (CPE) or other formal, structured education in patient counseling. The education shall be *not less than* six (6) hours in length and shall be pre-approved by the Board and shall be three (3) hours of counseling and three (3) hours of prospective drug review. Documentation of satisfactory completion of the education shall be submitted to the Board. This education is in addition to the thirty (30) hours of continuing pharmacy education required every two years for license renewal.

9. Respondent shall file a sworn report with the Board upon completion of the above conditions attesting to her compliance with all the terms and conditions of this Stipulation and Consent Order.

10. Respondent shall pay a civil penalty of \$250.00 within 30 days of the date of approval of this Stipulation and Consent Order by the Board. Respondent shall deliver a check made payable to the Treasurer of the State of Iowa to the Executive Secretary/Director of the Board. The check shall be deposited into the general fund of the State of Iowa.


11. The Respondent shall obey all federal and state laws, rules, and regulations substantially related to the practice of pharmacy.

12. This proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect to either party. If the Board approves this Stipulation and Consent Order, it shall be the full and final resolution of this matter.

13. This Stipulation and Consent Order is voluntarily submitted by Respondent to the Board for its consideration on the 15 day of September, 1999.


