COMES NOW the Iowa Board of Pharmacy (“Board”) and files this Notice of Hearing and Statement of Charges against Angelic Strommer (“Respondent”), 402 E Ross St., Toledo, Iowa 52342, pursuant to Iowa Code sections 17A.12(2) and 17A.18(3). Respondent’s Iowa pharmacy technician registration number 1429 is currently active and expires on January 31, 2016.

A. TIME, PLACE, AND NATURE OF HEARING

Hearing. A disciplinary contested case hearing shall be held on August 26, 2014, before the Board. The hearing shall be held during the morning session beginning at 9:00 a.m. and shall be located in the Board conference room located at 400 S.W. 8th Street, Des Moines, Iowa.

Presiding Officer. The Board shall serve as presiding officer, but the Board may request an Administrative Law Judge from the Department of Inspections and Appeals make initial rulings on pre-hearing matters, and be present to assist and advise the Board at the hearing.

Hearing Procedures. The procedural rules governing the conduct of the hearing are found at 657 Iowa Administrative Code rule 35.19. At the hearing, you may appear personally or be represented by counsel at your own expense. You will be allowed the opportunity to respond to the charges against you, to produce evidence on your behalf on issues of material fact, cross-examine witnesses present at the hearing, and examine and respond to any documents introduced at the hearing. If you need to request an alternative time or date for the hearing, you must comply with the requirements in 657 Iowa Administrative Code rule 35.16. The hearing may be open to the public or closed to the public at your discretion.

Prosecution. The Office of Attorney General is responsible for representing the public interest (the State) in this proceeding. Copies of pleadings should be provided to counsel for the State at the following address:

Communications. You may contact the Board office at (515) 281-5944 with questions regarding this notice and other matters relating to these disciplinary proceedings. You may not contact individual Board members in any manner, including by phone, letter, or e-mail, regarding this Notice of Hearing and Statement of Charges. Board members may only receive information about the case when all parties have notice and the opportunity to participate, such as at the hearing or in pleadings you file with the Board office and serve upon all parties in the case.

B. LEGAL AUTHORITY AND JURISDICTION

Jurisdiction. The Board has jurisdiction in this matter pursuant to Iowa Code chapters 147, 155A, and 272C (2013).

Legal Authority. If any of the allegations against you are founded, the Board has authority to take disciplinary action against you under Iowa Code chapters 147, 155A, and 272C (2013) and under 657 Iowa Administrative Code chapter 36.

Default. If you fail to appear at the hearing, the Board may enter a default decision or proceed with the hearing and render a decision in your absence, in accordance with Iowa Code section 17A.12(3) and 657 Iowa Administrative Code rule 35.21.

C. CHARGES

Count I

WORKING AS AN UNCERTIFIED PHARMACY TECHNICIAN

Respondent is charged with assisting a pharmacist with technical functions without a current pharmacy technician registration in violation of 657 Iowa Administrative Code rule 3.3, 3.6 pursuant to Iowa Code section 155A.6A(5), and 657 Iowa Administrative Code rules 3.30(1) and 36.1(4)(v).

D. FACTUAL CIRCUMSTANCES


1. Respondent was issued Iowa pharmacy technician registration number 9421 in 2004.
2. Respondent did not obtain national certification by December 31, 2013.
3. All uncertified technicians were required to become certified no later than December 31, 2013.
4. Prior to December 31, 2013, the Board communicated to Ms. Strommer that she must be certified by December 31, 2013, or she would need to register as a pharmacy support person.
5. A routine inspection performed on January 24, 2014, at Shopko revealed that Angelic Strommer, registration number 9421, was employed as an uncertified technician.
6. Respondent has since obtained national certification.

E. SETTLEMENT

This matter may be resolved by settlement agreement. The procedural rules governing the Board's settlement process are found at 657 Iowa Administrative Code rule 36.6. F. FINDING OF PROBABLE CAUSE




Pursuant to Iowa Code sections 17A.10 and 272C.3(4) (2013), the Iowa Board of Pharmacy ("Board") and Angelique Strommer ("Respondent") enter into the following Settlement Agreement to settle a disciplinary proceeding currently pending before the Board.

The allegations contained in a Statement of Charges against Respondent shall be resolved without proceeding to hearing, as the Board and Respondent stipulate as follows:

1. The Board has jurisdiction over the parties and the subject matter of these proceedings.
2. Respondent was issued Iowa pharmacy technician registration #1429, which is currently active and expires on January 31, 2016.
3. A Statement of Charges was filed against Respondent on April 30, 2014.
4. Respondent has chosen not to contest the allegations, and acknowledges that, if proven in a contested case proceeding, the allegations would constitute grounds for the discipline described herein.
5. Upon the Board's approval of this Settlement Agreement and Final Order, Respondent is hereby **CITED** for working as an uncertified pharmacy technician and **WARNED** that Respondent's failure to comply with the laws governing the practice of pharmacy in the future could result in further discipline.
6. Respondent agrees to pay a civil penalty in the amount of two-hundred fifty dollars (\$250). This civil penalty shall be made payable to the Treasurer of Iowa and mailed to the executive director of the Board within thirty (30) days of the Board's approval of this Settlement Agreement and Final Order. All civil penalty payments shall be deposited into the State of Iowa general fund.
7. This Settlement Agreement is the resolution of a contested case. By entering into this Settlement Agreement, Respondent waives all rights to a contested case hearing on the allegations contained in the Statement of Charges, and waives any objections to this Final Order.
8. Respondent is freely and voluntarily entering into this Settlement Agreement.


9. Respondent acknowledges that she has a right to be represented by counsel on this matter.
10. The State's legal counsel may present this Settlement Agreement to the Board *ex parte*.
11. This Settlement Agreement is subject to approval by a majority of the full Board. If the Board fails to approve this Settlement Agreement, it shall be of no force or effect to either the Board or Respondent. If the Board approves this Settlement Agreement, it shall be the full and final resolution of this matter.
12. This Settlement Agreement, when fully executed, is a public record and is available for inspection and copying in accordance with the requirements of Iowa Code chapters 22 and 272C.
13. The Board's approval of this Settlement Agreement shall constitute a **FINAL ORDER** of the Board.

This Settlement Agreement and Final Order is voluntarily submitted by Respondent to the Board for its consideration on the 2nd day of June, 2014.
