COMES NOW, the Complainant, Lloyd K. Jessen, and states:

1. He is the Executive Director for the Iowa Board of Pharmacy and files this Statement of Charges solely in his official capacity.
2. The Board has jurisdiction in this matter pursuant to Iowa Code Chapters 155A and 272C (2007).
3. The Board issued Jacqueline Topp (hereinafter, "Respondent") a pharmacy technician registration number 13643, authorizing her to serve as a pharmacy technician subject to the laws of the State of Iowa and the rules of the Board. Respondent's registration is current and active through March 31, 2009.
4. Respondent's address of record is 2617 Morton Avenue, Des Moines, Iowa 50316.
5. At all times material to this statement of charges, Respondent was employed as a pharmacy technician at Walgreens Pharmacy, 1330 East University Avenue, Des Moines, Iowa 50316, and Walgreens Pharmacy, 3501 Ingersoll Avenue, Des Moines, Iowa 50312.

A. CHARGES

COUNT I – UNLAWFUL POSSESSION OF PRESCRIPTION DRUGS

Respondent is charged pursuant to Iowa Code §§ 155A.6(7) and 155A.21 (2007), and 657 Iowa Administrative Code § 36.1(4)(h) with unlawful possession, distribution and use of prescription drugs.

COUNT II – VIOLATING LAWS RELATED TO PHARMACY; CONVICTION OF CRIME

Respondent is charged pursuant to Iowa Code §§ 124.403, 155A.6(7) and 155A.21 (2007), and 657 Iowa Administrative Code § 36.1(4)(i), with violating state laws related to the distribution of prescription medications, including controlled substances, and the practice of pharmacy.

COUNT III – UNLAWFUL POSSESSION OF CONTROLLED SUBSTANCES

Respondent is charged pursuant to Iowa Code §§ 155A.6(7) and 124.403 (2007), and 657 Iowa Administrative Code § 36.1(4)(j) with unlawful possession and use of controlled substances.

COUNT IV – FRAUD IN OBTAINING A REGISTRATION

Respondent is charged pursuant to Iowa Code §§ 155A.6(7) and 155A.23 (2007), and 657 Iowa Administrative Code § 36.1(4)(a) with fraud in obtaining a technician registration.

B. FACTUAL CIRCUMSTANCES

The circumstances supporting the charges are set forth on Attachment A.

WHEREFORE, the Complainant prays that a hearing be held in this matter and that the Board take such action as it may deem to be appropriate under the law.

VOLUNTARY SURRENDER OF PHARMACY TECHNICIAN REGISTRATION

I, Jacqueline M. Topp, a resident of Des Moines, Iowa, of my own free will and without any mental reservation and not as a result of any inducement, promise or threat on the part of anyone, do hereby voluntarily surrender my pharmacy technician registration in the State of Iowa, number 13643, to the Iowa Board of Pharmacy, for an indefinite period of time. This surrender of registration shall become effective upon the notarized signature of the registrant, Jacqueline M. Topp, on this voluntary surrender document.

I, Jacqueline M. Topp, of my own free will and without any mental reservation and not as a result of any inducement, promise or threat given or made by any representative, officer, or employee of the Iowa Board of Pharmacy, or of any other state official, do hereby further acknowledge that by voluntarily signing this surrender statement that I am knowingly and willingly giving up the exercise of the following legal rights:

- (1) My right to a formal hearing before the Iowa Board of Pharmacy on the matter of my continued registration as a pharmacy technician pursuant to Iowa Code Chapter 155A (2009).
- (2) My right to be represented by an attorney in preparation for and during such formal hearing before the Iowa Board of Pharmacy.
- (3) My right to submit evidence and to have witnesses called on my own behalf at such formal hearing.
- (4) My right to be represented by an attorney in this matter at this time.

I, Jacqueline M. Topp do hereby acknowledge that pursuant to 657 Iowa Administrative Code § 36.13, a pharmacy technician registration which has been voluntarily surrendered shall be considered a revocation of registration with respect to a request for reinstatement, which will be handled under the terms established by 657 Iowa Administrative Code § 36.13, which provides as follows:

Any person ... whose pharmacy technician registration ... has been revoked or suspended must meet the following eligibility requirements for reinstatement:

1. **Prerequisites.** Must have satisfied all the terms of the order of revocation or suspension or court proceedings as they apply to that revocation or suspension. If the order of revocation or suspension did not establish terms and conditions upon which reinstatement might occur, or if the license, registration, or permit was voluntarily surrendered, an initial application for reinstatement may not be made until one year has elapsed from the date of the board's order or the date of voluntary surrender.

....

3. **Proceedings.** All proceedings for reinstatement shall be initiated by the respondent who shall file with the board an application for

reinstatement of the license, registration, or permit. Such application shall be docketed in the original case in which the license, registration, or permit was revoked, suspended, or relinquished. All proceedings upon petition for reinstatement, including all matters preliminary and ancillary thereto, shall be subject to the same rules of procedure as other cases before the board. The board and the respondent may informally settle the issue of reinstatement. The respondent may choose to have an informal reinstatement conference before the board, as provided in rule 657—9.24 (17A,124B,147,155A,272C).

4. **Burden of Proof.** An application for reinstatement shall allege facts which, if established, will be sufficient to enable the board to determine that the basis for the revocation or suspension no longer exists and that it will be in the public interest for the license, registration, or permit to be reinstated. The burden of proof to establish such facts shall be on the respondent.

5. **Order.** An order for reinstatement shall be based upon a decision which incorporates findings of facts and conclusions of law and must be based upon the affirmative vote of a quorum of the board. This order shall be available to the public as provided in 657 – Chapter 14.

I, Jacqueline M. Topp, hereby further agree that I will not engage in any of the activities of a pharmacy technician in the State of Iowa for which a registration is required.



1. On May 4, 2009, Respondent executed a voluntary surrender of her pharmacy technician registration number 13643.
2. On June 2nd, 2009, the Board reviewed Respondent's voluntary surrender of her pharmacy technician registration and agreed to accept it.
